Proposed Removal from Office and Recall (Members of the Scottish Parliament) Bill

Introduction

A proposal for a Bill to introduce new measures on removing an MSP from office, including additional grounds for removal and new processes for removal, such as recall. Proposed new grounds for removal include where an MSP does not participate in parliamentary proceedings for a given period without valid reason or receives a prison sentence lower than the current threshold for automatic removal.

The consultation runs from 20 January 2022 to 13 April 2022.

One example is former MSP Derek Mackay who [redacted] and failed to attend parliament sessions following the revelations about his conduct, while still receiving full

salary and expenses. Similarly, the first minister has been caught on more than one occasion overtly [Redacted] to either parliament itself, or a committee of the parliament.

A statute is required. My reason for stating this is, the Sturgeon/Salmond debacle and subsequent committee of enquiry, has clearly demonstrated that there are those elected members who will [Redacted] citing 'selective memory' when presenting evidence at such inquiries. Such actions are more difficult to argue when being cross-examined by proper, legally trained lawyers / Sheriff's / judges, added to which, is the potential to charge a person with either contempt of court, or perjury.
